PENALTIES FOR NON-COMPLIANCE

Failure to comply with EPR regulations could result in substantial fines, mandatory product recalls, or restrictions on business operations.

EPR (Extended Producer Responsibility) compliance refers to the legal obligation imposed on producers, importers; and brand owners to manage the end-of-life of their products, including take-back, and disposal.

- **Circular Economy:** Encourages resource efficiency and the development of sustainable business models.

Possible Penalties

Failure to comply with EPR regulations can lead to significant penalties, including:

- **Fines:** Substantial financial penalties for non-compliance.
- **Operational Restrictions:** Outright bans on production, saieports.


